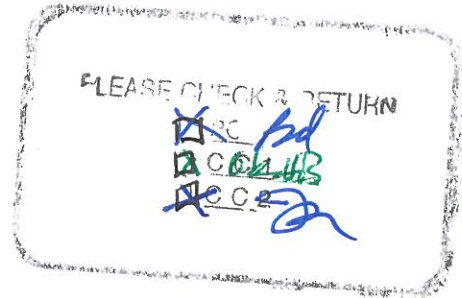

Informational Items

Resource Management: Director Kevin Barnes provided the Commission with updates on projects around the County. Barnes explained that the old mail room located at 933 N. Robberson has been vacated and he is ready to turn the keys over to the Juvenile office. Barnes informed Commission of an upcoming meeting with the manufacturers of the windows located at the PSC that are currently having glazing issues.

Greene County Sheriff's Office: Major Royce Denny provided an update on inmate population. 943 inmates with a total of 260 federal inmates and a total of 147 housed out of county. Denny also gave an update on the warrants division.

Juvenile: Chief Juvenile Officer Bill Price explained that his office has received a \$750,000.00 grant for enhancing family treatment court. Abuse and Neglect numbers are up and have been climbing since August.

WHEREAS, Section 58.700, Mo.Rev.Stat, requires the Greene County Commission to appoint a Medical Examiner; and




