

Free Counseling for Businesses Wanting to Sell to Government

The purpose of the Missouri Procurement Technical Assistance Center (MO PTAC) is to help businesses perform in the area of government contracting at the federal, state and local levels according to Allen Waldo, procurement counselor. Remember, government entities literally buy everything.

"I see some unusual government solicitations like taking care of the Army Mule mascot at West Point, a beached sea turtle vet in Hawaii, bagpipe instructors for military funerals, and crickets to feed to animals at the Dickerson Park Zoo in Springfield," said Waldo.

MO PTAC is funded by the Department of Defense through a cooperative grant from the Defense Logistics Agency (DLA) according to Allen Waldo, procurement counselor.

The Springfield office is part of the University of Missouri Extension's Business Development Program and is physically located with the MSU Small Business Technology and Business Development Center (SBTDC) in the Plaster Center for Free Enterprise Building (eFactory).

According to Waldo, roughly one-half of the active clients (over 100 locally) for the Springfield office are located in Greene County or a county directly adjacent. These businesses include construction companies, IT companies, interior design firms, architectural firms, engineering firms, manufacturing companies, and various retail/service companies.

Allen Waldo, shown on the cover, was recognized Oct. 24 for his work in procurement with the Missouri Chamber of Commerce and Industry Extension Business Award

MO PTAC services include registrations to do business with both the federal government and the state of Missouri and assistance with obtaining socio economic certifications including minority owned, woman owned, veteran owned, and HUBZone. In addition, MO PTAC services can assist businesses in researching governmental opportunities and in marketing their products/services to the government.

Generally, MO PTAC can offer professional counseling in every area of government contracting. As they are taxpayer funded, all counseling services are at no cost to their clients.

Their unique programs at the Greene County Youth Academy are helping develop leadership, citizenship and practical daily living skills among the county's at-risk youth, helping them build relationships and exposing them to resources and tools that can them build better lives and more productive futures. Bringing 4-H into the juvenile center is a great way to impact young lives. The team is already exploring new ideas, such as programming for the parents of juvenile offenders.

Greene County Receives Association Honors at Extension Summit



David Burton was presented the new "connections" award by University of Missouri Extension Association (UMEA) in recognition of unique and outstanding engagement efforts.



OPERATIONS:

The maintenance crews have been involved in routine activities including the following:

DISTRICT 1 CREW

- Crews installed a culvert drainage pipe on FR 136 and replaced a pipe and cleaned the ditch on FR 97 and FR 156.
- Road repairs were completed on Scenic and FR 60.
- Shoulder improvements were completed at the following locations: FR 83, FR 129, FR 125 and FR 26.
- Leaning and diseased trees were removed from the ROW at the following locations: Geri St, FR 35, FR 168, and FR 28. Crews also removed trees and brush from the roadways due to tornadic and strong straight-line winds.
- The Brush crew responded to requests of service at the following locations: Aaron, Brookside, FR 65, FR 5 and FR 140.
- The West Side crew performed their annual snow plow drill this month. The trucks were rigged and inspected to prepare for winter weather
- Other tasks for the month included: trash and animal removal, street sweeping, inspections and maintenance of equipment, etc.

DISTRICT 2 CREW


