ORDER OF THE GREENE COUNTY COMMISSION SPRINGFIELD, MISSOURI

DECLARATION OF LOCAL EMERGENCY

WHEREAS, a novel Coronavirus (COVID-19) and it's variants continues to spread throughout the world, including the United States; State of Missouri and County of Greene; and

WHEREAS, a significant increase in COVID-19 cases generated primarily from a rapidly spreading and highly communicable variant in conjunction with low community vaccinations has led to a crisis level healthcare response exceeding earlier COVID-19 thresholds; and

WHEREAS, the State of Missouri has extended its State of Emergency in response to the COVID virus; and

WHEREAS, after consultation with City, County and State officials it is the judgment of the Presiding Commissioner of the County of Greene, there exists emergency circumstances located in Greene County, Missouri requiring extraordinary and immediate corrective actions for the protection of the health, safety, and welfare of the citizens of the County of Greene; and

WHEREAS, to prevent or minimize injury to people, damage to property and maintain supply chain resilience resulting from this event;

NOW, THEREFORE, pursuant to the authority vested in the Greene County, Missouri Commission by local and state law;

WHEREFORE, IT IS ORDERED:

- 1) That all necessary sections of this County of Greene Emergency Management Declaration will be implemented; and
- 2) That the following measures also be implemented:
 - A. The local Emergency Operations Plan ("EOP") is hereby activated to the degree as indicated by the County Director of Emergency Management; and
 - B. The Emergency Operations Center ("EOC") is hereby activated to the level as indicated by the County Director of Emergency Management; and
 - C. The Commissioners direct the County Director of Emergency Management to coordinate the County's activities of emergency response, to work with local partners, as well as, state and federal authorities, to take all appropriate action needed to alleviate the effects of this emergency, to aid in the continuation and/or restoration of essential public services, and to take any other emergency response actions deemed necessary to respond to this incident.
 - D. The Commissioners direct the County Director of Emergency Management to promulgate such rules, policies and guidance as is necessary and appropriate to implement this Order; and
 - E. The Commissioners direct the Interim Director of the Springfield-Greene County Health Department to exercise such authority granted by law, to take all appropriate action needed to alleviate the effects of this emergency, to aid in the continuation and/or restoration of essential public health and medical services, and to take any other emergency response actions deemed necessary to respond to this incident on behalf of the citizens of Greene County.

IT IS FURTHER ORDERED this declaration of local emergency shall be effective at X:XX x.x. on July XX, 2021 and shall expire only upon further Order declaring the emergency no longer exists. A copy of this Order shall be filed in the office of the Greene County Clerk before 5:00 p.m. this date and copies of said order shall be printed and available for distribution to the public in the office of the County Clerk.
