The meeting was called to order at 4:01pm. The meeting was held virtually.

(Action 1) David Burton motioned to accept the minutes from the August 25, 2022 meeting as written. The motion to accept the minutes was seconded by Dr. Mark Maynard. The motion was unanimously approved.

## Applications for Consideration and Action by the ARPA Advisory Council

(Action 2) David Burton motioned to read and review the applications on page 1 of the small business applications spreadsheet (056-22 through 377-22). Application 067-22 2 Rivers Inc (Midnight Rodeo) until further information could be provided to the advisory council. The remaining applications and their respective award amounts were reviewed and read in the following order.

## ARPA 2022 Fall Nonprofit Grant Program Discussion

Dr. Lyle Foster discussed the following:

- The online portal for the grant program will close on September 14, 2022.
- The review process for Tier 3 applications will commence immediately after the portal closes.
- Greene County staff members will begin to categorize applications by their requested amount and collect necessary information to ensure compliance with all federal guidance.
- Council members will be provided with a review sheet to standardize the review process.
- During the Community Impact Program, some applicants requested permission to view their scores once funding decisions had been reached. Similarly,

Bridget Dierks discussed the following:

- Council members should use a numbering system to summarize their review of each nonprofit application. A numbering system could help frontload some of the administrative challenges council members may experience in the review process.

Keith Ray Mackie discussed the following:

- During CARES, reimbursement for existing projects was preferred over new capital projects. During ARPA, the council may determine that different funding methods are appropriate at this stage of the recovery from COVID-19.
- Council deliberations and review sheets must be made available to the public in accordance with the State of Missouri's Sunshine Law.
- Council members should bring their favorite apps to each council meeting, removing a numerical evaluation from the review process.

Additional discussion items include:

- Applicants may bundle multiple projects into one application. The council will determine how many projects are eligible for funding.
- CIP recipients and the Greene County Auditor's Office are meeting to create grant agreements.

(Action 3) Dr. Mark Maynard motioned to adjourn the meeting. The motion was unanimously approved.
